For warranty registration, send the completely filled up Product Warranty Certificate and a copy of a proof of purchase thru email or by post office within ONE (1) month from the date of purchase.

If the serial number is removed, obliterated, and defaced, or the unit is installed faultily, tampered with or altered by anyone other than a duly authorized service personnel of PMPC or its PASC, this warranty will be considered NULL AND VOID.

Supplied or external accessories (*) indicated in the operation instruction are excluded from this warrant. Exterior surface, paint finish, light bulb, glass shelves, and all other surface parts damaged due to mishandling by the user and excluded from this warranty.
