



   Instruct user to keep it in a safe place along with the air conditioner instruction manuals.
- The QR Code includes information required to set up the WLAN Adaptor.

### **Precautions for Installation setup and WLAN Adaptor**

# **MARNING**

- Turn off the circuit breaker of the units before installation.
- Select an installation location which is rigid and strong enough to support or hold the WLAN Adaptor, and select a location for easy maintenance.
- Use only the parts specified by Panasonic as supplied accessories.
- Ensure cables are installed properly so that external forces cannot affect them.
- Disassembly and modification of the WLAN Adaptor is not permitted under any circumstances.
- The WLAN Adaptor must be installed by the sales dealer or installer.
- When installing the WLAN Adaptor, use appropriate protective equipment and tools for safety.
- The WLAN Adaptor should be securely installed in accordance with the USER'S MANUAL.
- Electric work must be performed by authorised personnel in accordance with the local regulations and the instructions detailed in the USER'S MANUAL.
- To avoid malfunctions caused by radio wave interference, keep the WLAN Adaptor away from devices such as other wireless device, microwaves and the device that use 2.4 GHz signal. Depending on the area, the module may not be available.
- Attach the electrical cover to the indoor unit securely.
- Make sure to connect the WLAN Adaptor to the P.C. board and terminal board of the indoor unit properly.

- Do not use the WLAN Adaptor near to automatic control equipment (automatic door, fire alarms, etc.).
- In case of an abnormal condition (such as a burning smell), stop the indoor unit and turn the breaker OFF.
- Do not operate with wet hands.
- Do not splash water on the WLAN Adaptor or use it in the bathroom.

# **WLAN Adaptor Installation**

## **Basic Wiring Diagram**

Irrespective of the number of indoor units, the WLAN Adaptor must be used together with a remote controller.


A remote controller must be connected and it should be set as the "main unit" in the main-sub remote controller settings.

- Refer to the remote controller installation instructions for details on how to make the main-sub settings for the remote controller.
- Total length of remote controller wiring: Within 500 m (Remote controller wiring between indoor units is within 200 m)
- Number of units that can be connected for group control


Indoor units : Up to 8 units
 WLAN Adaptor : 1 unit
 Wired remote controller : 1 unit

 The system operates irrespective of the indoor unit you choose to connect the WLAN Adaptor and remote controller to.

## **Example of standard installation**

Example: With a 4-way cassette indoor unit

## Connect the communication lines to the indoor unit.

Thread the leads through the catches in the electrical box.


Fix in place with the included clampers

- Lead wires with crimper terminals should be connected to the remote controller terminal board.
  - (The lead wires with crimper terminals have no polarity.)
- Lead wires with connectors should be connected to the T10 connector.
- Fix the communication lines in place with the included clampers.
   Make sure the clampers hold the parts coated in white.
- There may be left over lead wires depending on the type of indoor unit.
   Tie back left over lead wires with the included clampers.

# Remove the top case.

Use a flat head screwdriver or similar tool to push in the catch on the bottom case and remove the top case.

Take care not to break the catch when pushing with the screwdriver.



## **Q** When attaching the bottom case to the wall

(For installation on a wall surface)

Screws (supplied): 2

Attach the bottom case to the wall with the UP mark facing upwards. Please ensure screws are tightened firmly. Do not overtighten screws as this may damage the casing.

Ensure that the screws do not contact metallic parts within the wall.



# Attach the top case.

Fit the upper catches before fitting the lower catch.

Take care not to pinch the communication lines in the case.



When fitting the lower catch, press down on it with a flat head screwdriver or similar tool and then fit the top case onto it. Note that applying too much pressure to the flat head screwdriver may result in damage to the catch.


# **Connecting Network**

- Initial settings use the QR Code. (Included with the USER'S MANUAL supplied with the product.)
   The QR Code is also used when adding product users and when resetting.
- The QR Codes must be left with the customer after setting up.
- The QR Code includes information required to register the device. The code should therefore be stored so that they cannot be viewed by people other than those with the proper authority.
- When multiple products are to be used, the QR Codes must be kept for each individual product.

The serial numbers can be used to relate the products themselves and their QR Codes.

Establish network connection to the internet via Wireless mode.

## Turn on the power supply to the indoor unit.

- The POWER LED will be lit (green).
- The LINK LFD will not be lit.

 It will not be possible to make network settings for approximately 3 minutes after turning on the power of the WLAN Adaptor due to initial settings being performed.

# Starting "Panasonic Comfort Cloud"

### 3.1 Create New Panasonic ID



Use "Panasonic Comfort Cloud" app as an option to control the air conditioner.

- For new user, select "Create an account".
- For registered user, login using your Panasonic ID and password.


- Confirm the wireless router is connected to the network and the router has access to the internet.
- Confirm the Wireless LAN of the smartphone is activated.
- Smartphone and air conditioner should be connected to the same wireless LAN.
- Ensure Wireless LAN is broadcasting SSID.

#### Add new air conditioner device

- The air conditioner needs to be registered before using "Panasonic Comfort Cloud" app.
- **1.** At My Home screen, tap "+" to add new product.



Select the "Commercial air conditioner" and choose the "WLAN Adaptor".





# WLAN Adaptor Q & A

## **Initial setting**

"Panasonic Comfort Cloud" app cannot be installed in smartphone.	Check if OS of the smartphone is compatible.  The APP is not guaranteed to work with all versions of Android™  OS.
WLAN Adaptor and router cannot be connected.	<ul> <li>Confirm that the POWER LED is on.</li> <li>Check the following if the LINK LED does not light.</li> <li>Ensure the router's WLAN signal reaches the WLAN Adaptor, the SSID is not hidden, the MAC address setup is enabled for the WLAN Adaptor, the router's dual band signal is enabled for 2.4 GHz connection.</li> <li>Check the network connections. (Refer to Page 11) Refer to the smartphone and router installation manual for detail.</li> <li>Check the router settings. A router function (such as band steering for example) may be trying to connect the unit to the 5 GHz band, making it impossible to connect. Turn off the router function if this is the case.</li> </ul>
Register additional air conditioner to "Panasonic Comfort Cloud" app.	To set register additional units, follow the "Add new air conditioner device" procedure, as detailed at the beginning of this manual. To easily distinguish each air conditioner unit, It is recommended to uniquely name each device accordingly.
Register additional user to control the air conditioner.	Download "Panasonic Comfort Cloud" app and create new Panasonic ID. Follow initial setting. Approval from administrator (first user) is required to complete the registration. For administrator approval, select the Menu. Choose "Owner" and select "User List" to approve additional user.


Suspicious unauthorised access to the air conditioner (WLAN Adaptor).	Reset the WLAN Adaptor to manufacturing default condition by referring to "To transfer or dispose the WLAN Adaptor. When resetting the WLAN Adaptor because you have forgotten the password." method in the next section. Complete initial connection setup.
Change of smartphone's model.	Ensure the smartphone compatibility. Install "Panasonic Comfort Cloud" app and login using your Panasonic login ID and password.  Complete by initial connection setup.
Change of WLAN Adaptor.	Change the WLAN Adaptor and then, use "Panasonic Comfort Cloud" app to select Menu. Choose "Owner" and "Replace device". This shall be performed by authorised service dealer.
Replacement of router.	From "Panasonic Comfort Cloud" app, select Menu . Choose "Owner" and select "Change router settings".
Cannot find the QR Code.	The QR Code is affixed to the back cover of the manual supplied with the product.  If you have lost the QR Code, use the AP mode (P.16) to setup.
QR Code cannot be read.	Wipe the QR Code clean if it is dirty.  If the QR Code can still not be read, use the AP mode (P.16) to setup.
Error occurs after reading QR Code.	You may be trying to read the wrong QR Code. Confirm that the serial number on the product and the serial number on the QR Code match.  If you cannot find a QR Code with a matching serial number, use the AP mode (P.16) to setup.
Do not know the password of the device.	No password is set when first registering the product. If you are asked whether you have a device password, select "No". A password has been set when registering any time after the first time, such as when adding a user. Select "Yes" and enter the device password that was set when first registering the product (P.15 or P.17). If you have forgotten the device password, refer to "When resetting the WLAN Adaptor because you have forgotten the password.", and reset the WLAN Adaptor to the manufacturing default condition.

# **Firmware Update Function**

This product has functionality for connecting to the Panasonic firmware update server over the Internet to automatically update the device firmware to the latest version. To update the firmware, the device will do check, once per day, whether its firmware is the latest version after power up. And if an update is required, the update is applied and the device restarts automatically. Operations are not possible while the device is being restarted (Requires a maximum of five minutes).
